Life business as of June 30 accounted for 25.6% of the \$40.39 billion in premiums and 45.4% of the \$151.93 billion in assets associated with international insurance companies, as categorized by the Cayman Islands Monetary Authority, up from 10.9% of the \$22.51 billion in premiums and 22.6% of the \$71.24 billion in assets a year earlier.

Cayman Islands SPACs and their directors have not been exposed to this litigation to the same extent.
